#### **FIRST SESSION**

## <u>DISCUSSION REGARDING 10000 NEW HAMPSHIRE AVENUE PURCHASE AND SALE AGREEMENT</u>

International President Costa began a discussion regarding the current status of efforts by ATU-TEC Properties, LLC (ATU-TEC) to sell 10000 New Hampshire Avenue. He discussed the purchase and sale agreement (PSA) entered into by ATU-TEC and WLA Enterprises, Inc. (WLA) on July 5, 2023, which made closing contingent on WLA securing approval from governmental authorities for WLA's development plan. International President Costa informed the Board that WLA had been unable to secure approval for its development plan, but that it was willing to move ahead with the PSA if the parties could agree to new terms in light of its need to change its plan. The Board discussed the terms of a February 26, 2025 offer made by WLA to amend the PSA.

## MOTION APPROVED TO ENDORSE THE AMENDMENT OF THE PURCHASE AND SALE AGREEMENT

Upon a motion duly made and seconded, the General Executive Board voted unanimously, in a roll call vote, to endorse ATU-TEC Properties, LLC, amending the purchase and sale agreement on the terms in WLA Enterprises, Inc.'s February 26, 2025 offer.
